- * You can synchronize a SharePoint library to your computer, and make the documents available to you when you are offline.
 - # Make sure that the OneDrive for Business client is installed on your machine.
 - Navigate to the library you want to synchronize.
 - ## Click the Synchronize the current document library icon (library-new-sync).
 - Click Sync Now.
- * To map a network drive to a SharePoint Online library, follow these steps:

 - Click in an empty area of the Explorer window address bar, and then copy the URL of the library.
 - # Right-click the Computer icon from the Desktop, or within Windows Explorer, and then click Map Network Drive.
 - Click the Connect to a Web site that you can store your documents and pictures link, and then click Next two times.
- * Opening a SharePoint Library in a traditional "Explorer View" can make it easier to work with a number of files or folder maintenance tasks.

If it is a once-off requirement you could simply open the Library in Explorer view – from the SharePoint Library toolbar or you may also Map a drive from Windows explorer for ongoing access to the Library.
