The BBU is designed to power the SP long enough for the system to store SP cache content to the M.2 SSD device before powering down. The BBU includes sensors which communicate its charge and health status to the SP. In the event the BBU is discharged the SP will disable cache until the BBU has recharged. In the event the BBU has faulted or cannot sustain enough charge, an alert will be generated.

When a snapshot is attached, Unisphere provides the option to create a copy of the snapshot in case the administrator wants to preserve the current snapshot view for future use.

Application developers can access REST API with any programming or scripting language capable of making HTTP requests, without requiring a separate client.

Note: The Unisphere CLI (UEMCLI) is a tool that provides us with the CLI access to perform the same actions as one would on the Unisphere web interface.

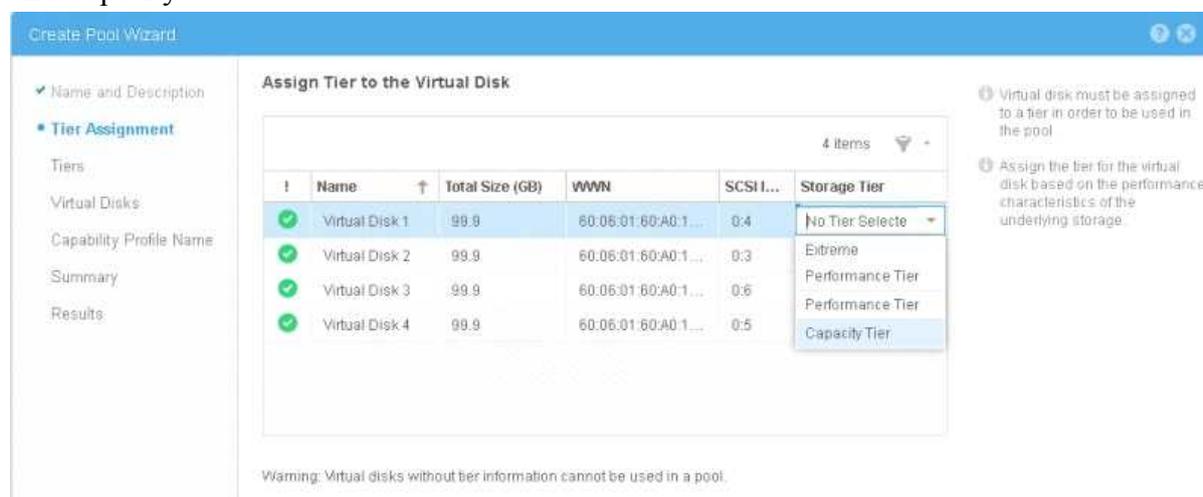
